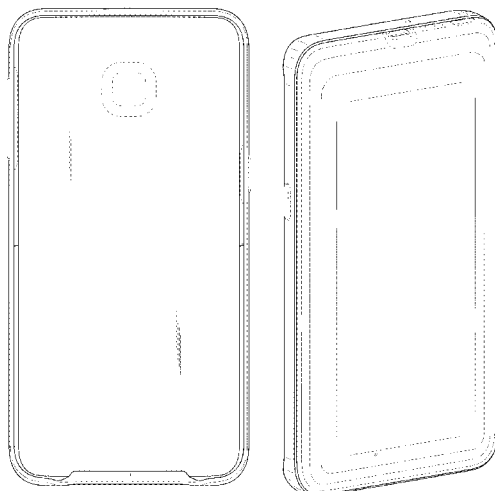
(57) **CLAIM**

The ornamental design for a wireless charger case for electronic communications device, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a wireless charger case for electronic communications device, showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left-side view thereof;
FIG. 5 is a right-side view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom view thereof; and,
FIG. 8 is a rear perspective view thereof.

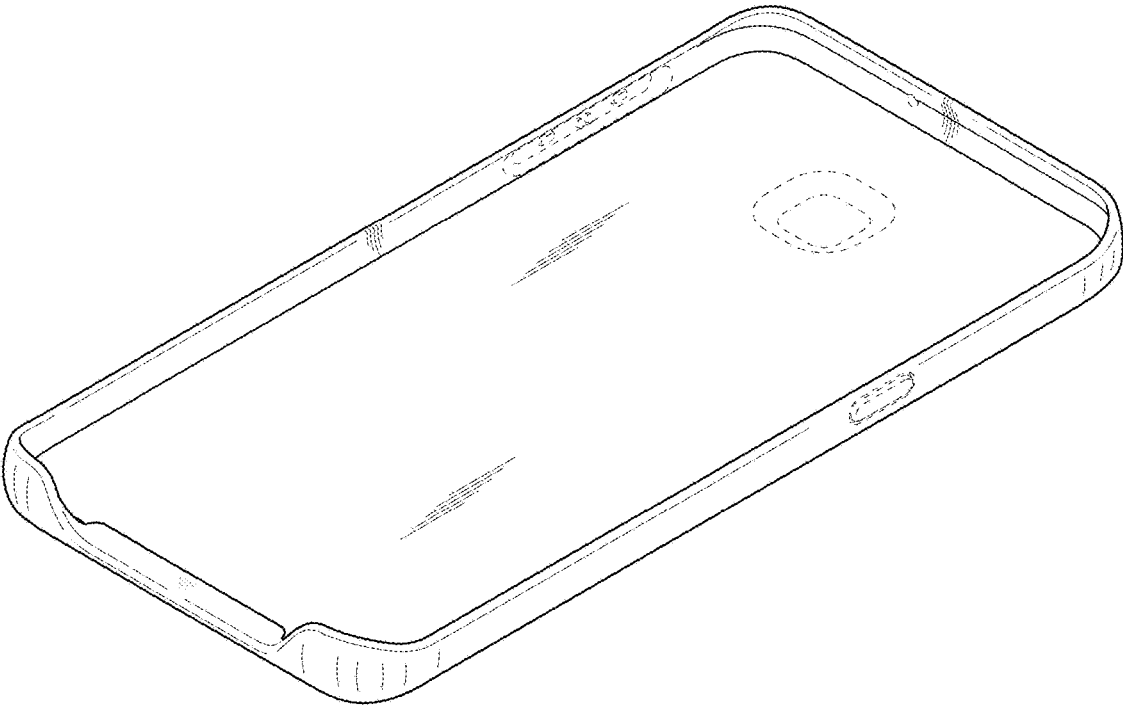

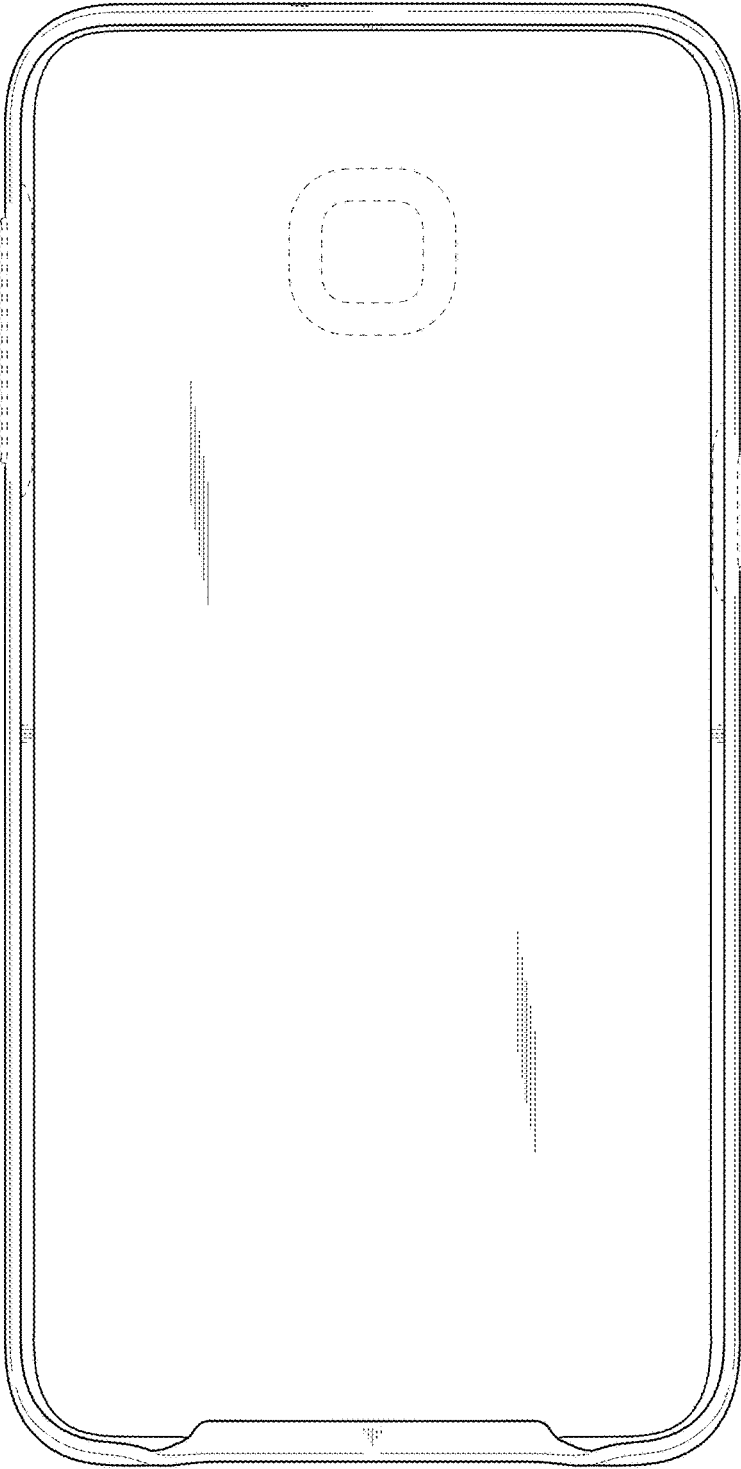

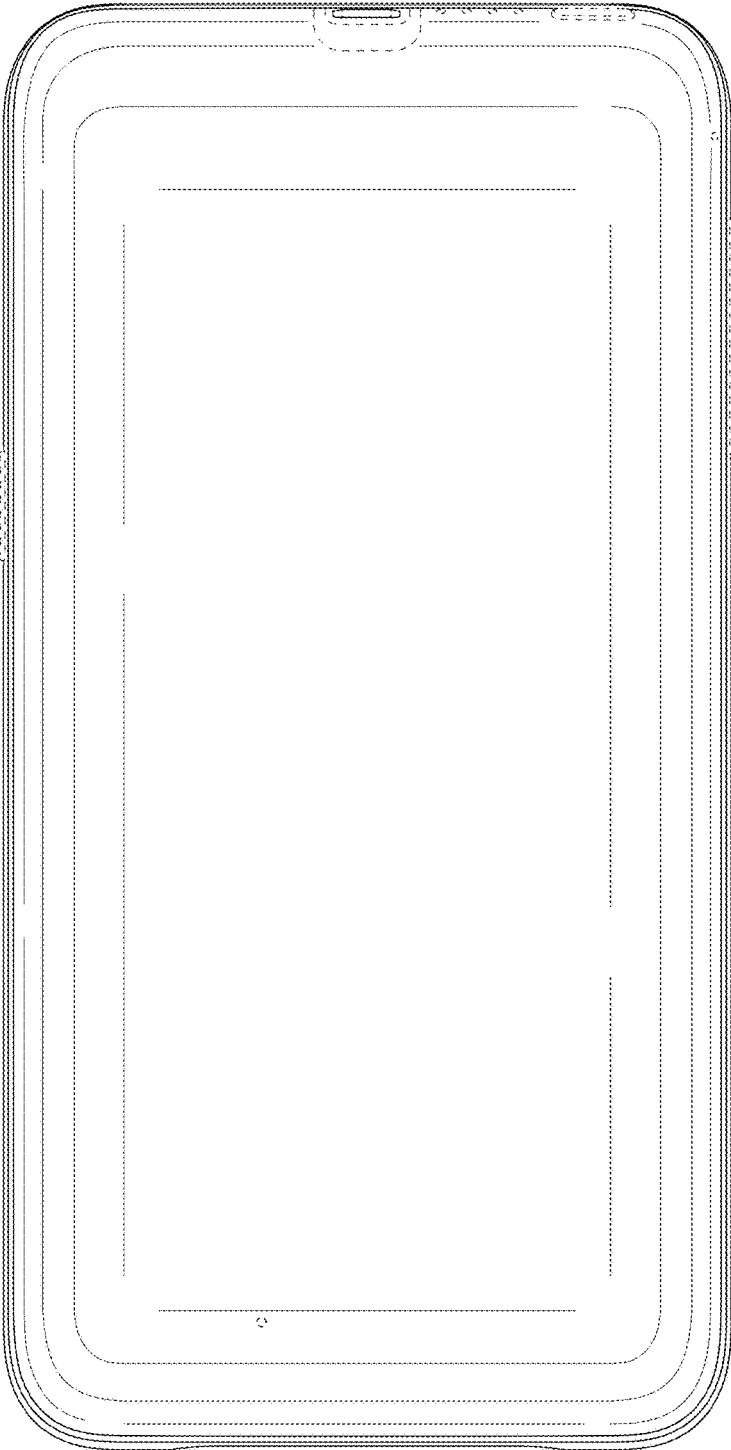

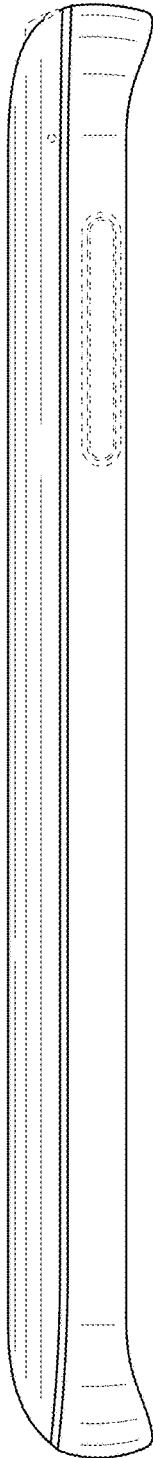

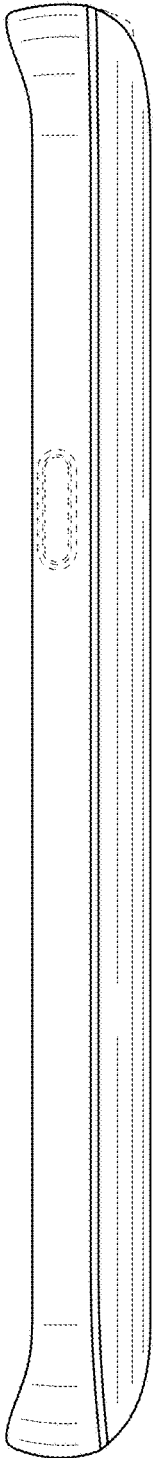

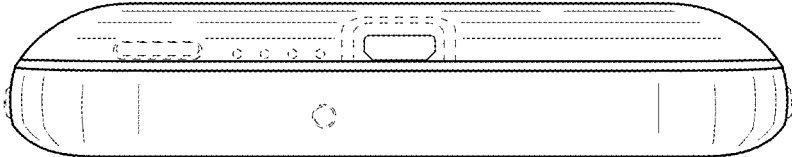

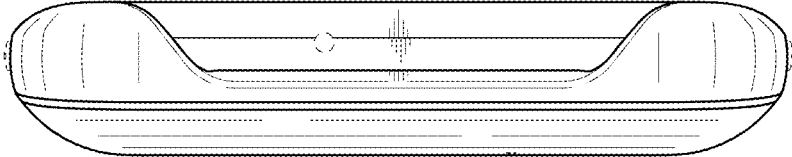
